## I. Position Specifics

We are so thankful you are interested in applying to be part of our leadership as a Volunteer Coordinator this summer at Forcey Day Camp 2026! Before going any further, please familiarize yourself with the Day Camp ministry and make sure you understand our expectations for staff members, some of the material is new for 2026.

Qualifications for Volunteer Coordinator	Must be a growing follower of Christ; Must have a heart to see others come to faith in Christ; Must have attained a sustained reputation of personal godliness; Must have an awareness of strengths and weaknesses and be willing to grow in each area; Must be comfortable and eager to lead a group of staff (mostly teenagers and young adults) in spiritual ministry.
Nature of Ministry at Forcey Day Camp	Our purpose at Forcey Day Camp is to connect campers to Christ. Therefore, sharing Jesus Christ with our campers (aged 5-12) in word and deed is the focus of the ministry. A weekly schedule is followed with some different activities each week including games, crafts, field trips, swimming, etc. Camp will be divided into three sections (K-1 <sup>st</sup> grade, 2-4 <sup>th</sup> grade, 5-6 <sup>th</sup> grade campers) and campers will follow a different schedule tailored to their age group. Each staff person will primarily work with one of the three age groups, with each group working as a team to reach its campers for the Lord. Counselors lead campers through the day engaging in all activities and taking the opportunities to minister to camper's needs. The Volunteer Coordinator functionally leads the volunteer staff in the ministry of the camp by providing oversight, support, and spiritual direction.
Nature of Volunteer Coordinator Position	The Volunteer Coordinator helps assist in volunteer hiring and training. Leads volunteers through the weekly ministry to train and disciple them to be the most effective they can be while at FDC. Oversee all volunteer activities. Oversee any issues within the volunteer group and necessary discipline. To care for and encourage the volunteers in their roles.
Availability	<p>With only 8 weeks of ministry, each staff member is expected to make camp a priority, and availability will be considered in hiring:</p> <ol style="list-style-type: none"> <li>1) Be available from 9-4 during Training Week (week before camps starts)</li> <li>2) Be available from at least 7:45am – 4:10pm, M-F during the camp season (June 29-August 7), and one to two days/wk until 6:00pm (pre-assigned).</li> <li>3) Two additional 40-hour weeks (pre-camp and during camp) is expected. Therefore, the Volunteer Coordinator is a part of the pre-camp preparation and must be ready to prioritize camp activities.</li> </ol> <p>Pre-planned time off is possible but the nature of the position requires a commitment to daily participation, and full availability will be <u>strongly</u> considered in hiring. <i>Availability limitations must be explained at the interview.</i></p> <p>Other availability expectations for the Volunteer Coordinator include Family Orientation (6/18 at 7:30pm AND 6/20 at 10:30am), Ministry Commissioning service (TBA), Family Night (7/30 after camp day until approx. 8:30), and a general commitment and flexibility to attend pre-planned staff events.</p>

## **VII FINGERPRINTING & FIRST-AID TRAINING**

### **Fingerprinting:**

Forcey Day Camp staff members are required by Maryland state law to submit fingerprints for a criminal background check. Forcey Day Camp requires all new staff to get fingerprinted before camp begins. There will be a time during training week to get fingerprinted, if you cannot do this, you will need to get fingerprinted on your own time before camp starts (we will reimburse). These records will be stored by FDC under lock and key year-round. *If you have worked at FDC previously, you will not need to do this. Please check one of the following.*

### **CPR AND FIRST-AID TRAINING:**

Current CPR and First-Aid certification is **required**. Forcey Day Camp is offering this training to staff free of cost before camp (date to be determined). Any Volunteer Coordinator who does not have current certification is expected to obtain a CPR and First-Aid certification. If you get certified outside of our training week for the summer, the camp will reimburse only up to the per person amount paid for our offered training.
